प्रेस-विज्ञप्ति

आयोग द्वारा उ० प्र० न्यायिक सेवा सिविल जज (जू०डि०) परीक्षा-2022 की प्रारंभिक परीक्षा का आयोजन दिनांक 12-02-2023 को किया गया था, जिसमें कुल 50837 अभ्यर्थी सम्मिलित हुए थे। प्रश्नगत परीक्षा का परिणाम दिनांक 16 मार्च, 2023 को घोषित किया गया था। प्रारंभिक परीक्षा के आधार पर कुल 3145 अभ्यर्थियों को मुख्य परीक्षा हेतु सफल घोषित किया गया था। मुख्य परीक्षा का आयोजन दिनांक 23, 24 व 25 मई 2023 को किया गया था, जिसमें कुल 3019 अभ्यर्थी सम्मिलित हुए थे। मुख्य परीक्षा का परिणाम दिनांक 01 अगस्त, 2023 को घोषित किया गया था, जिसके आधार पर 959 अभ्यर्थियों को साक्षात्कार हेतु सफल घोषित किया गया। अभ्यर्थियों का साक्षात्कार दिनांक 16 अगस्त, 2023 से 28 अगस्त, 2023 के मध्य सम्पन्न हुआ, जिसमें सभी 959 अभ्यर्थी उपस्थित हुए।

2-योग्यता का सम्मान कर राष्ट्र के निर्माण में योगदान करते हुये लगभग 6½ माह में प्रश्नगत परीक्षा के आधार पर 303 रिक्तियों के सापेक्ष 302 अभ्यर्थियों को सफल घोषित किया गया है। एक रिक्ति का परिणाम मा० उच्चतम न्यायालय में योजित रिट पिटीशन (एस) सिविल संख्या-581/2023 में पारित अन्तरिम आदेश के आलोक में घोषित नहीं किया गया है।

3-संदर्भित परीक्षा में कुल 165 महिला अभ्यर्थी सफल घोषित हुई हैं।

4- प्रश्नगत चयन परिणाम में सफल घोषित जिन अभ्यर्थियों के सम्मुख प्रोविजनल (Prov) अंकित है उनसे यह अपेक्षा है कि वे निर्धारित समयान्तर्गत वॉछित अभिलेख आयोग कार्यालय में अवश्य प्रस्तुत कर दें अन्यथा उनका चयन परिणाम/अभ्यर्थन निरस्त कर दिया जायेगा।

5-प्रश्नगत परीक्षा परिणाम आयोग की वेबसाइट <http://uppsc.up.nic.in> पर उपलब्ध है। चयनित अभ्यर्थियों की संस्तुतियाँ शीघ्र ही शासन को प्रेषित कर दी जायेंगी तथा उसके पश्चात् अभ्यर्थियों के प्राप्तान्क तथा श्रेणीवार कट ऑफ अंक की सूचनार्यें शीघ्र ही आयोग की वेबसाइट पर प्रदर्शित की जायेंगी। इस सम्बन्ध में सूचना का अधिकार अधिनियम, 2005 के तहत प्राप्त प्रार्थना पत्र स्वीकार नहीं किये जायेंगे और न ही उन पर विचार किया जायेगा।
